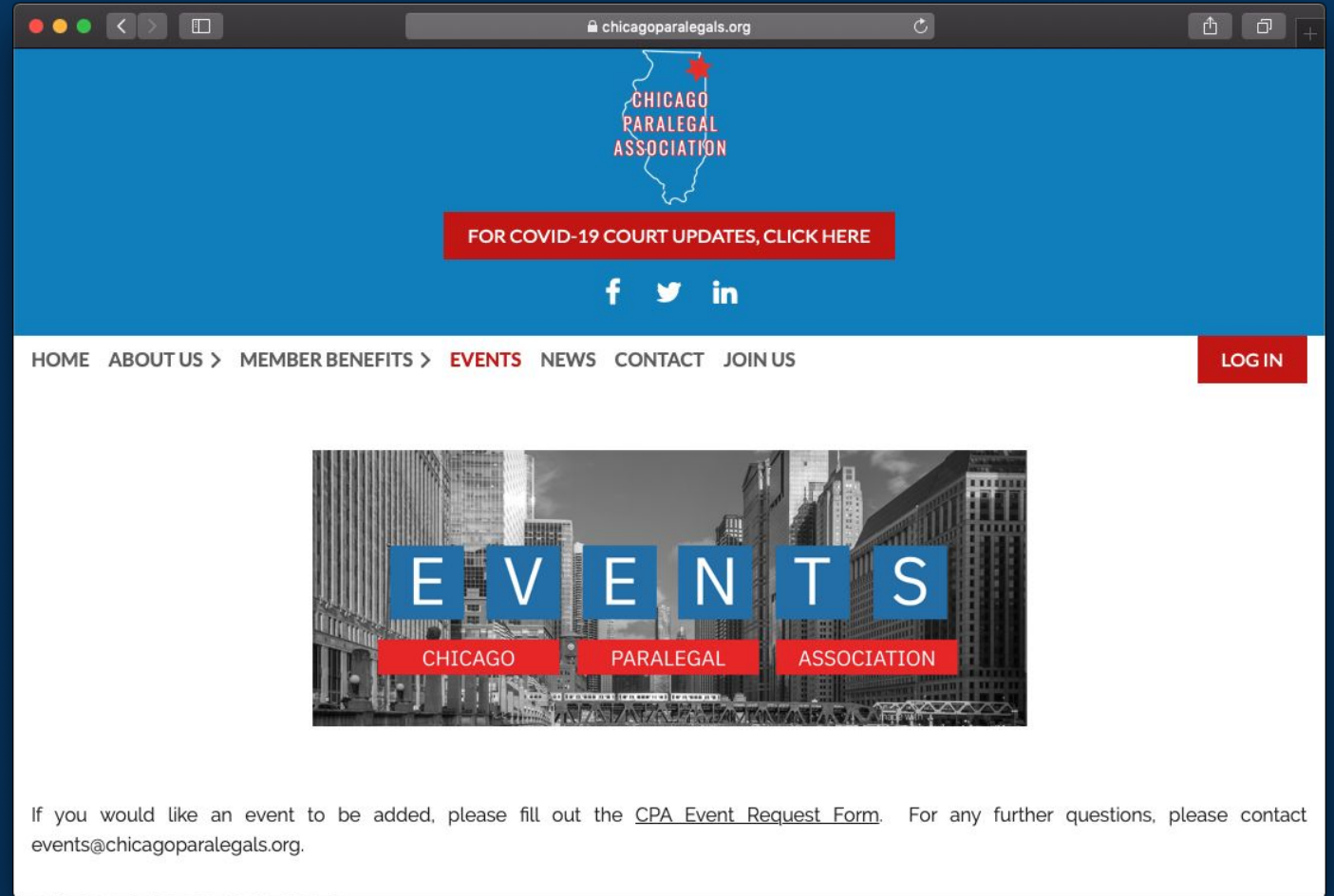

Electronic Filing

eFile civil cases and court documents on the Clerk's Office website's eFile Portal. Go to www.cookcountyclerkofcourt.org and select "eFile Your Case".

Email Services

Select services are available to customers via email submission, including:

- Copies of documents/court file
- Certified copies of documents **(This will be a flat certification stamp)**
- Certified copies of divorce decrees **(This will be a flat certification stamp)**

Please direct requests to the appropriate District/Department/Division (see email address list).

Note: requests for copies/certifications must be paid in advance.
